

DESCRIPTION OF WORK:

General Description: Bid package for the UCR SOM Clinical Skills and Simulation Suite. Scopes of work for this bid package include the partial demolition of the ground floor of the existing Orbach Science Library, and complete build out of the Clinical Skills and Simulation Suite. The extent of the build out will be determined by the different alternates selected, if any.

The University has bid and awarded a CM at Risk Contract to Kitchell Contractors (hereafter "CM/Contractor"). CM/Contractor is responsible for bidding and awarding all subsequent subcontractor packages. The successful Subcontractor Bidder shall sign a Subcontract Agreement directly with CM/Contractor, and shall be bound by all the terms of the contract between University and CM/Contractor. Refer to "Contract Bid Package," which contains the contract between University and CM/Contractor, attached to the subcontract bidding documents and incorporated by this reference.

<u>Bid Package 1 Complete Building Scope (this contract):</u> This Bid Package consists of Demolition, Mechanical, Electrical/Low Voltage, Plumbing (MEP) systems, Fire Alarm, Fire Sprinkler systems, Concrete, Roofing, Operable Partitions, and all Interior Finishes.

The University is reopening this invitation for prequalification as it has determined that it has an insufficient number of potential bidders to proceed to bid this Project. The University will receive Prequalification Questionnaires from prospective bidders who have not already submitted Prequalification Questionnaires on time in response to the first Advertisement.
