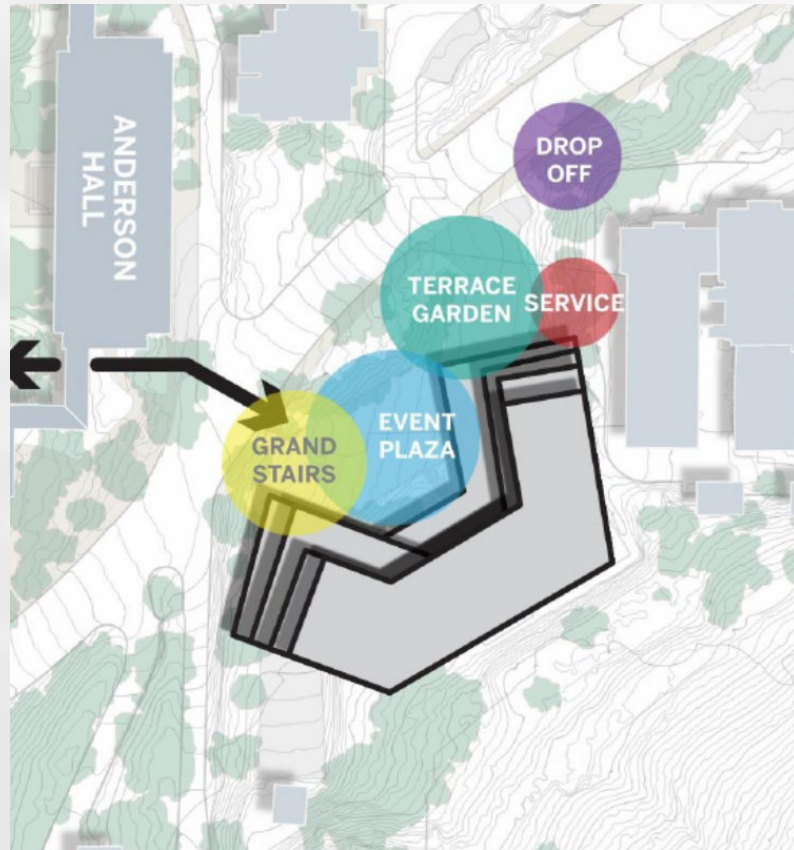


Site Goals

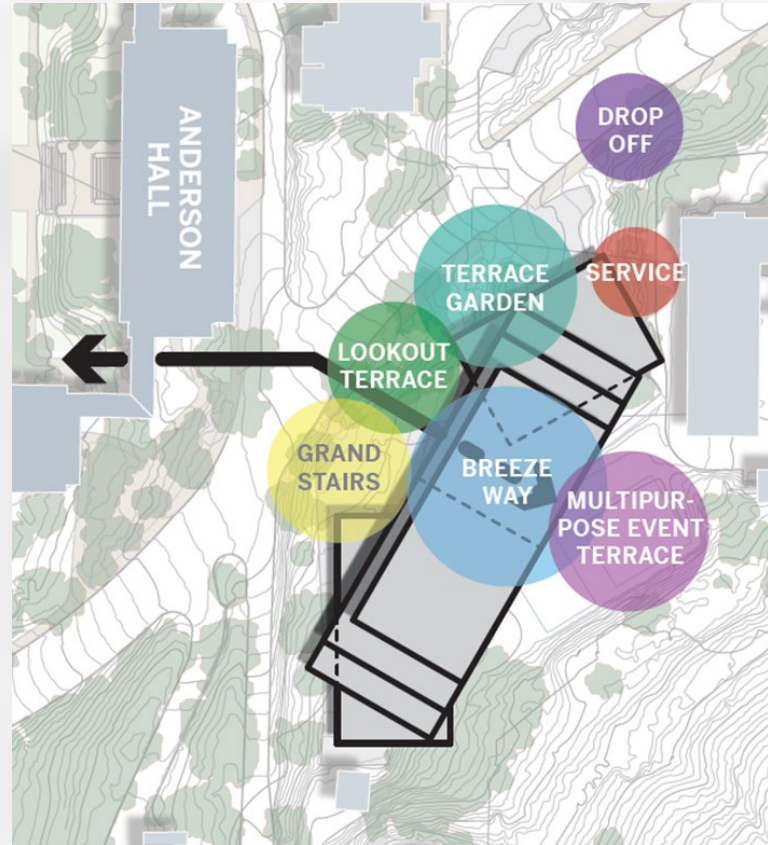
- Operational synergy with adjacent Anderson Hall

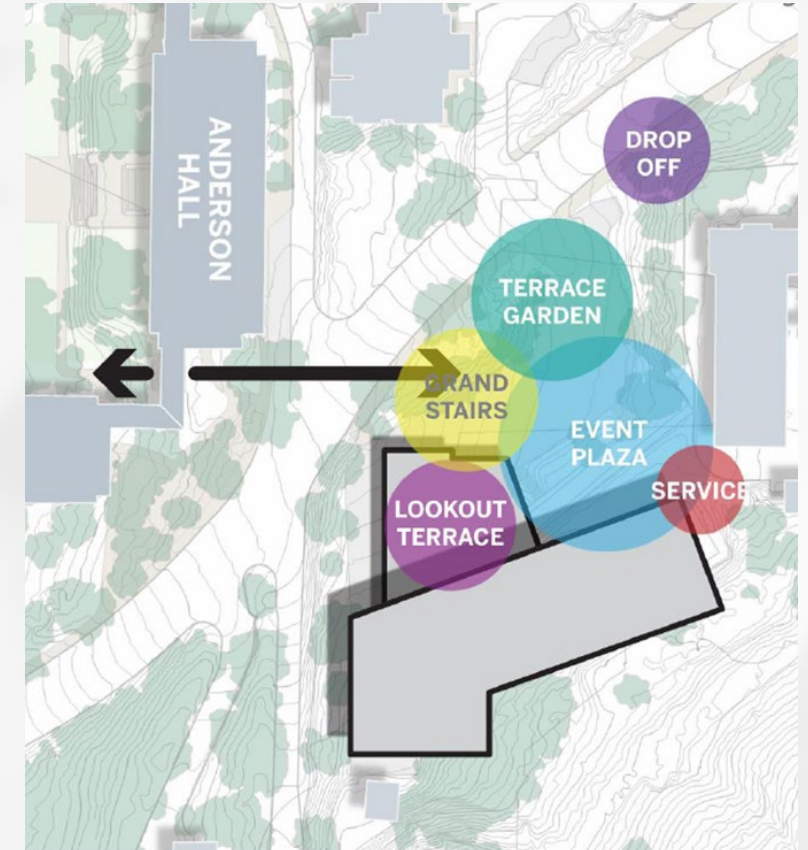
